+ Expenses: All fees are subject to additional charges when unusual conditions occur, unique circumstances, failure to obtain a permit in advance and/or abide by the permit terms and conditions that necessitate additional staff time or other expenses. Fees are set based on reasonable and customary charges for each service. Additional Expenses may include outside consultants, RCKC labor and equipment above and beyond customary charges for a service. A list of hourly charges for personnel and equipment normally used by the RCKC will be furnished upon request. Such charges are subject to change without prior notice and reflect necessary and actual costs for services.

+ Oxcart Fees: Fees levied on Oxcart applicants for Michigan road commissions permits.

**During times of weight restrictions, as set forth in Michigan Public Act (PA) 300 of 1949, as amended, (MCL 257.722 (8) commonly referred to as Seasonal Road Restrictions), and at any other time when conditions are unfavorable, a Permit will not be issued for overweight and/or overweight loads. A permit issued for overweight vehicles and/or overweight loads on a seasonal basis will not be valid during periods of reduced load restrictions. The RCKC reserves the right to refuse to issue a Special Transportation Permit when the condition of the road is such that above-legal load limitations would cause harm or injury to the highway.
