



#### Kalamazoo County Road Commission Road Fund Revenue Years Ended December 31, 2009 through 2013\*



# Kalamazoo County Road Commission Road Fund Expenditures Years Ended December 31, 2009 through 2013 \*







#### Kalamazoo County Road Commission Road Fund – Fund Balance For the Years Ended December 31, 2008 through 2013 \*\*




# Kalamazoo County Road Commission Unrestricted Fund Balance as a Percentage of MTF Revenue Comparison to Other Road Commissions \*

# Kalamazoo County Road Commission Overfunded Pension and Unfunded OPEB Obligations For the Years Ended December 31, 2009 through 2012\*


